FOR COMPA'S SUPPLIERS

According to the COMPA's Quality Policy, fixing the quality targets is mandatory. COMPA's objective is "zero defects goal", and if this objective is not met, there will be set intermediary targets on a determined period of time.

The fixed target and the PPM which will be monitored for all our suppliers, and in the case of not respecting it, the supplier will be asked for a plan of immediate corrective measures. Meeting the quality targets does not absolve the supplier from its obligations regarding process, complaints management and continuous improvement. Also, it doesn't absolve the supplier of its obligations regarding the guarantee, and COMPA's request for all the damages owed to a bad supply process. COMPA requests from its suppliers to meet the PPM objective as follows:
